I. Frequency of the communication between the Independent Directors and Certified Public Accountant:

- 1. The Independent Directors and Certified Public Accountant shall communicate with each other at least twice a year.
- 2. The Independent Directors shall communicate with the Internal Audit Supervisor individually for at least four times a year.

II. Communication between the Independent Directors and Internal Audit Supervisor

- 1. Periodic -
 - 1.1 The completed "Audit Report" is submitted to the members of the Audit Committee for inspection in an electronic form on a monthly basis. If there is any queries or instruction, the Internal Audit Supervisor will be informed of the queries or instructed to handle the matter by e-mail or telephone.
 - 1.2 The "Audit Report", status of audit, audit findings and the status of improvement of any abnormalities will be presented to the Audit Committee on a quarterly basis.
- 2. Irregular -
 - 2.1 Communicate by phone, email or meetings normally on how to enhance the value of the Company's audit and improve the efficiency and effectiveness of the Company's operation, and notify the members of the Audit Committee of any major irregularities according to law.
 - 2.2 The channels of communication between the Internal Audit Supervisor of the Company and the Audit Committee are diversified and unobstructed.
